Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

In May 2020, a school reopening survey showed school staff expressed concern with supporting student's emotional support and maintaining consistent expectations for protocols for the school.

In February 2021, parents were given a school re-opening survey in which 61.3% of parents were concerned with their child's social emotional development upon returning to the classroom in the spring of 2021. In February 2021, teachers were given a school re-opening survey which revealed 100% of teachers were concerned about their students' emotional well being upon returning to school.

Parent and teacher surveys were conducted in April of 2021 to gather information to identify areas of strength and concern in regards to aspects of school climate as well as areas to strengthen in terms of student and family engagement and areas to focus upon to expand student learning opportunities. The parent survey showed 77.8% of parents want to see more simulations and hands on learning experiences in classrooms and 70.4% of parents want more outdoor learning opportunities for their students. The teacher survey showed 71.4% teachers would like more support in providing students with classroom simulations and hands on learning experiences and 42.9% want more support in outdoor learning.

A student SEL survey was administered for grades 3-8 in the fall of 2020 and spring of 2021. The SEL surveys gathered information on the five SEL competencies as outlined by CASEL. The spring survey showed 30% of students in grades 3-8 believe they struggle to describe their feelings. A student climate survey was conducted in May to determine student needs and to gather information on students' connectedness to their school, teachers and peers. Ongoing assessment in both SEL and school climate will continue in future years.

Parent/Guardians will be informed of utilization of ELO funds through district memos, teacher newsletters and school board meetings.

A description of the LEA's plan to provide supplemental instruction and support.

The LEA's plan to support learning for our students of greatest need, as defined by the ELO prompt, is through strategic integrated student supports and training for staff. Stakeholders are all concerned for our children's emotional well being upon returning to school from a stressful and traumatic year of being away from the physical classroom and their peers. Mt Baldy School recognizes students must have a sense of belonging and emotional groundness in order to be ready and able to learn. According to CASEL (2021), "SEL interventions that address CASEL's five core competencies increased students' academic performance by 11 percentile points,

compared to students who did not participate in such SEL programs. Students participating in SEL programs also showed improved classroom behavior, an increased ability to manage stress and depression, and better attitudes about themselves, others, and school." Planned supplemental instruction and support for SEL includes:

- Curriculum for grades TK-8, including an SEL survey
- Consultant
- Staff training/ongoing support
- Substitute teachers for teachers to attend training
- Substitute teachers for instructional learning coaching cycles

In addition, there is a natural alignment between visual and performing arts and social emotional learning. "Standard VPA program activities help students to better understand concepts of dedication and self-confidence. VPA programming offers the opportunities for students to "practice and rehearse being self-aware, and making good decisions" (Edgar, 2017). Planned supplemental instruction and support includes visual and performing art consultant(s).

Furthermore, integrating environmental/outdoor learning supports student learning as described by Sharon Danks from <u>Green Schoolyards</u> (2021), "Living school grounds are richly layered outdoor environments that strengthen local ecological systems while providing place-based, hands-on learning resources for children and youth of all ages. They are child-centered places that foster empathy, exploration, adventure and a wide range of play and social opportunities, while enhancing health and well-being and engaging the community." Environmental/outdoor learning planned supplemental instruction and support includes:

- Consultant and consulting agency
- Staff training/ongoing support
- Substitute teachers to attend training
- Substitute teachers for instructional learning/coaching cycles
- Transportation
- Infrastructure

Targeted academic support will include paraprofessionals.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.

- c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

· An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
